The following is a final draft ancestral genealogy report prepared by Robert Atteberry for Michael Palmer. The information contained in this report was compiled almost entirely from records found on Ancestry.com. The launch point for this investigation was Elmer Claude Attebery, born sometime in the late 1800's, and interred at Lodi, California. This preliminary search data was supplied by Michael Palmer, with the statement that Elmer Claude Attebery was his maternal grandfather.

Utilizing this initial datum, a search of burial records led the researcher to a "Find-A-Grave" record for Elmer Claude Attebery, summarized as follows:

Utilizing the biographical information contained in this burial record, the researcher was subsequently led to the discovery of census records, Draft Registration records, marriage record, voter registration record, death record, city directory records, etc. Having established the primary biographical facts about Elmer Claude Attebery, the researcher was successful in tracing the ancestry of Elmer Claude Attebery through 10 successive generations of antecedents and descendants, from the family of Lucille Elizabeth Attebery and Charles Edward Palmer, all the way back to William Arthurbury and Ann Oliver of Morden Parish, Surrey County, England in the 17th Century.

The research was limited primarily to the Attebery lineage, with a few and limited forays into maternal branches. The data compiled from this research has been entered into a Public Tree on Ancestry.com, entitled *Elmer Claude Attebery Family*. This tree contains most of the known members of each generation of this Attebery lineage. Also, when available, the supporting records and documentation for each member of this lineage are appended to the profile of each respective member.

Based on previous work performed on the Atterbury/Arthurbury family, the researcher can stipulate that the lineages and familial connections contained in this immediate research and final draft report is supported by verifiable data, with only a few exceptions. These exceptions are the purported parentage of Charles H. Attebery, born about 1820 in Missouri having been Melchizadek Attebery and Mary Peebles, and the purported parentage of Melchizadek Attebery having been Charles and Sarah Arterbury.

The connection of Charles H. Attebery as a son of Melchizedek Attebery and Mary Peebles has <u>not</u> been absolutely confirmed or verified. In fact, none of the Public Trees on Ancestry.com for Charles Attebery and Nancy [Emily] Bristow show any knowledge of Charles' parents. The only site found online by the researcher claiming to know Charles' parentage is a profile post on Geni.com.¹ There is circumstantial evidence connecting Charles H. Attebery to the family of Melchizedek Atterberry, which if proven, is worthy of consideration. The "evidence" for connecting Charles H. Attebery as a son of Melchizedek Attebery falls into two primary categories: (1) allied family association, and (2) geographic proximities.

The allied family association is predicated on two intermarriages between Atteberys and Bristows from the same generation in the same general geographic location. If provable, such intermarriages between members of allied families are usually suggestive of close kinship connection. During the westward migration of Europeans across middle North America in the 19th Century, population was relatively sparse and widely distributed. Furthermore, the surnames of Attebery and Bristow were still relatively limited in numbers in the United States. The Bristow-Attebery intermarriages specifically identified in this current examination were reported as follows:

- Charles H. Attebery married Nancy Amelia [aka Emily] Bristow
- Sarah Attebery married James Patterson Bristow

The record of the intermarriage between Charles H. Attebery and Nancy [aka Amelia or Emily A.] Bristow is summarized as follows:

Admittedly, there is a problem with the bride's name given in this marriage record as "Nancy", yet the date and location of this marriage and the groom's name are very good matches for this having been a record of the marriage of our primary subject, Charles H. Attebery as further supported by the 1850 census record of the household of Charles Atterbery, summarized as follows:

Given the matching name of the head of household [Charles Atterbery], the location of Morgan County, IL [abutting Macoupin County to the northwest] being a relatively close fit with the marriage in Macoupin County, IL, and the age of the oldest child, James Edward born in Illinois in 1844, it seems highly probable that this was the same couple reported married on 5Feb1842. That being the case, then it seems reasonable to assume that Charles H. Attebery's wife was named Nancy [aka Emily] Bristow.

Then we have the marriage record of Sarah Attebery and James Patterson Bristow summarized as follows:

Further biographical evidence of this couple is found in the following summary of the 1850 census record for the James P. Bristow household:

The names, ages and location provide a high level of probability that this was the same couple married in Morgan County, IL on 23Dec1841. Does the fact that Charles H. Attebery and Sarah

Atteberry each married persons surnamed Bristow within three months of one another, and in adjacent counties suggest a kinship connection? Likewise, does a similar set of circumstances for Nancy Bristow and James Patterson Bristow suggest a kinship connection? All things considered, this researcher normally would be inclined to lean toward a close kinship connection between both these Atteberys and Bristows, possibly as siblings. However, does the possibility of such a kinship connection between Charles H. and Sarah Atteberry get us any closer to identifying their parents?

Before pursuing that discussion, let's first compare their respective demographics as shown in the census records. From the 1850, 1860 and 1870 census records, Charles H. Attebery consistently reported himself to have been born in Missouri in 1820. However, Sarah Attebery-Bristow reported herself born variously between about 1815-22, and three times in Kentucky and once in Tennessee. Given what is known of the migration paths of the Atteberry families out of South Carolina in the late 18th and early 19th Centuries, it seems more probable that Sarah, whoever she may have been, most likely was born in Kentucky. The fact that Charles H. Attebery and Sarah Atteberry each reported different places of birth does not negate the possibility of their have been siblings. Some branches of the Atteberry family are known to have migrated from Kentucky to Missouri and then to Illinois. So, it is entirely possible that they could have been from the same family.

As to whether Charles H. Attebery descended from Melchizedek Atteberry and Mary Peebles, this is an easier question to answer. Given Charles H. Attebery's reported place of birth in Missouri, it is a virtual certainty that he was not a son of Melchizedek. Such kinship is rendered a virtual impossibility by the fact that Melchizedek was recorded in both the 1820 and 1830 census records residing in Grayson County KY. Unless, he somehow magically moved from Kentucky to Missouri and then back to Kentucky between 1820 and 1830, it is possible to state with a fairly high level of certainty that Charles H. Attebery was not a son of Melchizedek Atteberry and Mary Peebles.

As for geographic proximity, it cannot be denied that the Melchizedek Atteberry family did eventual settle in very close proximity to the Charles H. Attebery family, as suggested by the following summary of the 1840 census:

Unfortunately, Ancestry has not indexed the composition of this household, but a review of the microfilm image does suggest that there were still four young males between 5 and 25 years, and three young females between 10 and 25 years living in Melchizedek's household. Such composition could have included a son named Charles H. born in 1820 and a daughter named Sarah born in about 1815. By 1850 Melchizedek had relocated his family to nearby Macoupin County as evidenced by the following record summary:

In 1850 Charles H. Attebery was recorded living in Morgan County, whereas James P. and Sarah Bristow were recorded living in Macoupin County. Although recorded living in the same county in 1850, the Melchizedek Atteberry household was recorded on page 73, whereas the James P. Bristow household was recorded on page 3. Sometimes it is possible to infer a strong familial kinship connection based on a family's juxtaposition with other family(ies) within the census record listings. However, due to the somewhat disparate separation between these families in the 1850 census, it is not possible to ascribe any degree of kinship. One final point to note is the fact that another household headed by a James Bristow was recorded on the same page with the James P. Bristow household, summarized as follows:

Given the relative ages of these two James Bristows (28 vs. 52) and the relatively close proximity in the census listing (same page), it seems highly probable that James and Polly Bristow were the parents of James Patterson Bristow. Also, given that James Bristow reported his place of birth having been Tennessee, and that Nancy [aka Emily] Bristow regularly reported her place of birth as Tennessee, it seems highly possible that Emily was a sister of James Patterson Bristow, and a daughter of James and Polly Bristow.

And, finally on the comparative analysis between Charles H. Attebery and Sarah Atteberry-Bristow, it is worth noting that James Patterson and Sarah named their first born son "Lewis" Bristow. Lewis was a rather unique given name during this time period. For what it's worth, it should be pointed out that Melchizedek and Mary named one of their sons Lewis W. Atteberry, and further, that two grandsons were named Lewis W. and Lewis B. Atteberry. These naming

conventions may lend weight to the argument that Sarah Atteberry may have been a daughter of Melchizedek and Mary Atteberry.

Thus far in our investigation of the possible ancestry of Charles H. Attebery, we have fairly reliably excluded Melchizedek Atteberry as his father, in spite of circumstantial evidence auguring in that direction. So, if not Melchizedek, then who might Charles' father have been? Perhaps the best information we have available for identifying Charles H. Attebery's parents is his reported date and place of birth, i.e., 1820 in Missouri. Armed only with Charles' name, and date and place of birth, the researcher then went in search of families that might possibly fit this criterion.

First, a brief disclosure of the researcher's typical methodology is in order. Since there is a wide range of corruptions for the spelling of the Attebery surname, the researcher, throughout this study, employed the use of "wildcards". Specifically, the Atteberry search criterion was universally constrained to the following form: "a*t*b*r*". Utilizing this search criteria within Ancestry databases will return all surnames beginning with the letter "a", and containing in this exact order, the letters "t", "b", and "r", plus any and all trailing letter combinations after the letter "r". This methodology has been utilized by this researcher for over 15 years of searching Ancestry databases for Atteberry ancestors. It has been proven very efficacious in locating the myriad corruptions known to exist for this surname, with the exception of instances where the letter "a" has been transcribed erroneously, or when the letter "t" had been corrupted to an "l", "f", "b" or "d". Minor alteration to the preferred search criteria may occasionally be warranted in order to ferret out those unique and unusual corruptions, i,e., Allerbury, Abburbury, Adderbury, etc.

That being said, the researcher conducted a search of the 1830 census for Missouri and compiled a listing of all of the Atteberry households summarized in the following Table 1:




Figure 1 – Missouri Territory Map – Circa 1812

Table 1 contains a compilation of all the male members of Atteberry households recorded in Missouri in 1830. The purpose of compiling this list of households was to establish that there were Atteberrys living in Missouri prior to 1830, any of which might have been the source of Charles H. Attebery, who was frequently reported having been born in Missouri about 1820. The land that ultimately became the State of Missouri in 1821, had previously been part of the Louisiana Territory, which encompassed a vast territory west of the Mississippi River. Upon the creation of the State of Louisiana in Apr1812, the remainder of the former Louisiana Territory became known as the Missouri Territory, generally as illustrated in Figure 1.

European immigrants likely began migrating westward across the Mississippi River and settling in the future State of Missouri shortly after the end of the War of 1812. Just when the various Atteberry families listed in Table 1 may have settled in Missouri is not known, but could have been virtually anytime between about 1813 and 1830. It is this researcher's belief that most of the Atteberrys listed in Howard County in 1830 were members of the James Atteberry family strand. James Atteberry Sr. is believed to have been born in about 1760/1 in Loudon County, VA. James Atterberry's households were recorded in Chester County SC in 1790 and in Grayson County KY in 1810, summarized as follows:

The fact that no record could be located for James Atterberry in 1800 is a strong suggestion that he had already relocated his family to Kentucky sometime between 1790 and 1800, probably around 1798/9, based on his disposal of land in Chester County before 1800. Kentucky census records did not commence until 1810, so anyone settling in Kentucky before that date would not be captured in any census record. If we compare the household compositions between 1790 and 1810, it seems fairly clear that James added five sons and three daughters to his family in that 20-year gap, and that he already had one son prior to 1790. That being the case, then it seems highly improbable that James Atterberry would have had a son named Charles H. Attebery, born in Missouri in 1820, unless perhaps he had married a younger woman as a 2nd wife. Also, the

1830 census record for James Atteberry's household in Howard County MO shows no evidence of any younger males still living at home (summarized as follows):

So, assuming that Charles H. Attebery's family was still resident in Missouri in 1830, we can safely state that his father was not James Atterberry Sr. That being the case, then Table 1 would seem to limit the possible candidate families for the parents of Charles H. Attebery to five households:

- 1. Simeon Atteberry, Chariton County MO
- 2. Zachariah Arterbury, Howard County MO
- 3. Edward Arterbury, Howard County MO
- 4. James Arterbury [Jr.], Howard County MO, and
- 5. William Atterbury, Union Ralls County MO.

In an attempt to further focus our search for the parents of Charles H. Attebery, we will now evaluate each of these five families to either include or exclude them from further consideration:

<u>Simeon Atteberry</u>: The identity of Simeon Atteberry is somewhat muddled. We can state with some certainty that he was descended from one of the nine presumed sons of William Arterbury, the Immigrant.

He was first recorded marrying in Hardin County KY, summarized as follows:

No further record was found for Simeon Atterbury until the 1830 census in Chariton County MO, summarized as follows:

It should be noted that Chariton County abuts Howard County immediately to the northwest. Remembering that it was Howard County in which the James Atterberry family settled sometime between 1810 and 1830, it might be significant that Simeon Atterberry should settle so close to the James Atterberry family. The next record found for Simeon Atterberry was a land grant application summarized as follows:

2Nov1837: Simon [sic] Atteberry of Monroe County, Missouri, was granted 40 acres, described as follows: "the north east quarter of the south east quarter of Section eleven, Township 55 (North), of Range 12W, in the District of lands subject to sale at Palmyra, Missouri…"²

However, it may also be noteworthy that Simeon Atterberry had relocated his residence roughly 120 miles south-southwest into Rives County (later subsumed into St. Clair and Henry County in 1841) as summarized in the following census record abstract:

It seems probable that Simeon Atterberry did not change locations between 1840 and 1850, but rather was simply reported in different municipalities that had undergone reorganization. The fact that Simeon Atterberry was not recorded as a head of his own household in 1810 suggests

that he likely was still living in his father's household. The identity of Simeon Atterberry is not known with certainty, insofar as the researcher has been able to ascertain, but it should be reported that there are a total of 436 public trees posted on Ancestry.com containing profiles of Simeon Atterberry. Of those trees, roughly 400 purport the father of Simeon Atterberry to have been Richard Atterberry I. The other 36 claim Michael Atterberry to have been Simeon's father. The researcher seldom lends much weight to public trees posted on Ancestry, and cautions against drawing any firm conclusions regarding Simeon's ancestry from those records.

It seems probable to the author that the myriad of public trees on Ancestry, which proffer Richard Atterberry as Simeon's father, probably have based that conclusion simply on the fact that Richard Atterberry II is documented to have named a son Simeon Buchanan Atteberry. If that were the sole basis for connecting Simeon Atterberry to Richard Atterberry I, it must be considered baseless and weak in the absence of any other supporting evidence. The researcher would merely point out that Simeon Atteberry's reported age in the 1850 census of 72 years would have him born in 1778. Such age would have made him an adult of almost 28 years when Richard Atterberry I wrote his LWT in Hardin County KY around 1806. In that Will and in associated Court records there was no reference to a son named Simeon.

Given that Simeon's marriage was recorded in Hardin County KY in Jul1812, it seems reasonable to conclude that he was residing in Kentucky at the time the 1810 census was recorded. Assuming that to have been the case, there were only two Atterberry households recorded in Kentucky in 1810 which could have contained a male adult fitting Simeon's demographics, namely Charles Atterberry or James Atterberry. None of Charles Atterberry's descendants are known to have moved to Missouri as early as 1830. All things considered, it is the researcher's opinion that Simeon Atterberry very possibly was a son of James Atterberry Sr. Assuming that to be the case, then Simeon Atterberry probably was one of the two males under age 16 reported in James Atterberry's household in Chester County in 1790.

Given the fact that Simeon Atterberry was not recorded anywhere in the 1820 census, it seems entirely possible that he could have relocated with James Atterberry's family from Kentucky to Missouri sometime between 1812 and 1820. Assuming that to have been the case, and given the fact that Simeon reported three males between 10 and 15 years in the 1830 census, it seems entirely possible that Simeon Atterberry could have been the father of Charles H. Attebery.

Zachariah Arterbury: The identity of Zachariah Arterbury is not known with certainty. There are a total of 396 public trees on Ancestry which contain profile pages for Zachariah Atterberry, born about 1778 in Chester County SC. A large majority of those profiles claim Zachariah's father to have been Charles Artberbury. A few claim either William Arterbury, Michael Arterbury, Richard Arterbury or Thomas Arterbury to have been his father. Also, a large number of these trees claim Zachariah's wife to have been either Naomi McKinsear, or simply Naomi (mnu). Again, the researcher cannot place much credence to the validity of these public trees, and has found absolutely no one offering any documentary evidence for Zachariah's ancestry, other than probably having been a grandson of William Arterbury, the Maryland Immigrant.

The earliest record found of Zachariah Atterbury was in the 1830 census record in Howard County MO. As illustrated in Table 1, Zachariah Arterbury was recorded with one young male

aged 5 to 10 years in Howard County MO in 1830. Zachariah, himself, was reportedly aged 40 to 50 years. Given that Zachariah was over age 40, it is probable that his eldest son may have been nearly the age of 10, which could make that son of an age matching that of Charles H. Attebery. Zachariah's households from the 1830 and 1840 census are summarized as follows:

There are inconsistencies/incongruencies between the compositions of these two households, which warrant our attention. But, first, it should be pointed out that the Ancestry summary of the 1840 household has transcribed the head of household as "J" Atterbury. On closer scrutiny of the actual microfilm image of that census page, the name appears to actually have been "Z" Atterbury. Zachariah was the only Atterbury during this time period whose first name initial began with the letter "Z". Given the matching first name initial, the location of Howard County, and the approximately matching household composition, the researcher is inclined to believe that this 1840 census record was of the household headed by Zachariah Atterbury.

Now for a discussion of the inconsistencies/incongruencies:

- 1. <u>Zachariah's age</u>: Zachariah's age was recorded as 40 to 50 years in both 1830 and 1840. Such age variance was not unusual, and should not be considered determinative in identifying the head of household.
- 2. Variance in male occupants: In 1830 there were recorded two young male occupants listed as follows:
 - Free White Persons Males Under 5:
 Free White Persons Males 5 thru 9:
 - In 1840 there were also recorded two young male occupants listed as follows:
 - 1. Free White Persons Males Under 5: 1
 - 2. Free White Persons Males 15 thru 19: 1

There appears to the researcher to be only two probable ways of interpreting the seeming discrepancy between these young male occupants, year-to-year:

1. The older male (aged 15 thru 19) in 1840 could have been the same person as the older male (aged 5 thru 9) in 1830. If this were the case, then it begs the question as to the disposition of the younger male (aged under 5) in 1830. It is conceivable that that younger male could have died between 1830 and 1840.

2. The older male (aged 15 thru 19) in 1840 could have been the same person as the younger male (aged under 5) in 1830, and the older male (aged 5 thru 9) in 1830 could have left his father's household or died by 1840.

Argument No. 1 appears to the researcher to be the most probable explanation for this discrepancy, given that the age ranges of the young males match perfectly, year-to-year. Admittedly, Argument No. 2 could also have been the case, and the slight variance in age ranges could simply have been a recording error. However, for the sake of our analysis of Zachariah Atterbury as a potential father of Charles H. Attebery, the truth of these arguments may become relevant. In argument No. 1 Zachariah would have had only two living "sons" in 1840, whereas Argument No. 2 would suggest the survival of three living "sons" in 1840.

3. Identity of Older Male in 1840: There was recorded an older male, aged 80 thru 89, living in Zarachiah's household in 1840. It seems probable that that older male would have been a kinsman of Zachariah, most logically either the father of Zachariah or his wife. If this elder Atterbury was the father of Zachariah, then that fact might be useful in establishing the parentage of Zachariah Atterbury. Many researchers claim that James Atterberry Sr. survived to about 1843, and purportedly was buried in Monroe County MO. The researcher has found no documentation to support these claims regarding the disposition of James Atterberry Sr. after 1830. If the purported demise of James Atterberry in 1843 were correct, then it seems possible that the elder male in Zachariah Atterberry's household in 1840 could have been James Atterberry Sr. If that were the case, then it might suggest that Zachariah was a son of James Atterberry.

No record was found for Zachariah Atterbury after the 1840 census. However, there were two later census records in 1850 and 1860, which could have been of the households of his widow. These trailing census records are summarized and discussed as follows:

As already stated, numerous public trees on Ancestry report the wife of Zachariah Arterbury as having been either Naomi, or Naomi McKinsar. The researcher has been unable to verify the name of Zachariah's wife. A few of the public trees also link Naomi, wife of Zachariah, to the foregoing census records from 1850 and 1860. The researcher cannot affirm or refute that the

Naomi listed in these census records was the widow of Zachariah. What can be stated with some certainty is that the three young persons listed in the 1850 household would appear to comport fairly closely with the gender and ages reported for the three young persons reported in Zachariah's household in 1840.

If we assume that the 1850 household headed by N. Atterberry was the household of Zachariah's widow and children, then we seemingly would have accounted for all of the living children of Zachariah Atterbery, unless we accept Argument No. 2, in which case there may have been an elder son (aged 5 thru10 in 1830) who had already moved out of his father's household by 1840. Such eventuality could allow for that elder son to have been Charles H. Attebery, who may have already left his father's household and possibly moved to Illinois. At this juncture in our analysis, the researcher in inclined to retain Zachariah Arterbury as the possible father of Charles H. Attebery. This possibility would seem to be strengthened, if Zachariah's father was Charles Arterbury. Zachariah may have been disposed to naming his 1st born son after his father.

<u>Edward Arterbury</u>: The reader may recall that Edward Arterbury was recorded in the 1830 census of Howard County MO immediately adjacent to Zachariah Arterbury in that listing. Further, that the researcher suggested that such close proximity in the census record may be a strong suggestion of a close kinship connection, possibly as brothers. According to the 1850 census Edward was born in South Carolina in about 1792, summarized as follows:

Many Atterberry family researchers claim this Edward Atterberry to have been a son of Thomas and Luraney Atterberry, including more than 200 of the 260 profiles appearing in public trees on Ancestry.com. The researcher found only one reference to "documentary" evidence of this kinship. In their tome entitled "The descendants of William Atterbury, 1733, English emigrant", Voncille Attebery Winter, PhD. and Wilma Attebery Mitchell wrote the following:

"Edward Atterbury, b. circa 1794, Chester County SC, d. circa 1847-50; in Howard County MO by 1823; married Jane ____; son Edward M. married 26Dec1850, Nancy Jane Ford; received Letters of Administration for estate of father in 1840."

The researcher has not been able to locate the referenced "Letters of Administration", but has no reason to doubt that the authors (Voncille Attebery Winter and Wilma Attebery Mitchell) had found this record and had confirmed that Edward Atterberry was granted administration over the estate of his father, Thomas Atterberry. Presumably, it was that document which they used to establish their published kinship connection of Edward Atterberry as a son of Thomas Atterberry. That being said, the researcher is inclined to accept that the Edward Atterberry recorded in the 1850 census of Howard County MO was a son of Thomas Atterberry. As for the identity of that Thomas Atterberry, his parentage is not quite so clear cut.

Most of the same public trees from Ancestry.com which have been cited above as containing profiles for Edward Atterberry also report his grandfather to have been William Arterbury Jr., 2nd eldest son of William Arterbury, The Immigrant. Voncille Winter and Wilma Mitchell also report William Atterbury Jr. as the grandfather of Edward Atterberry. The documentation for the kinship connection between Thomas Atterberry and William Atterberry as son and father relies almost exclusively on William Atterberry Jr.'s LWT (probated Jan1794), in which he named his wife, Bridget, and his three eldest sons: Thomas, William and James, two youngest sons: Nathan and Elijah, and four daughters: Mary, Sarah, Elender and Anne. Also, in the 1800 census of Chester County SC are listed the households of Thomas Atterberry and Bridget Atterberry listed immediately adjacent to each other. From these abutting census records in combination with the LWT of William Atterberry, it seems probable that these census records were for Bridget, the widow of William Atterberry, and for his eldest son, Thomas Atterberry [purported father of Edward Atterberry].

The author will not clutter these pages with all of the finer details of the record for Thomas and Bridget Atterberry, but suffice it to say that Thomas Atterberry, the presumed son of William Atterberry, Jr. and presumed father of Edward Atterberry, was recorded in three more consecutive census records in 1810, 1820 and 1830, in Kentucky. In 1820 and 1830 Thomas Atterberry was recorded living in Barren County KY. Family lore, and household compositions for Thomas Atterberry in Kentucky, suggests that his mother, Bridget, moved to Kentucky and lived with her son, Thomas, until his death in about 1836. After Thomas' death, Bridget is reported to have moved to Missouri, where she resided with her youngest son, Elijah, in 1840.

Assuming that Edward Atterberry was a son of Thomas Atterbury, then we must ponder just when he may have moved to Missouri, as he would need to be there by 1820 in order to have been the father of Charles H. Attebery. Three census records have been found in Missouri in 1830, 1840 and 1850, which the researcher believes may all have been for the same person, namely, Edward Atterberry, son of Thomas Atterberry, summarized in Figure 2, below:

The compositions of the 1830 and 1840 households appear to be a close match, even though the name for the head of household in 1840 is not definitive (appears only as "C" Atterberry). Both

the 1830 and 1840 census records were from Howard County, with the 1840 census location being more discretely identified as Moniteau Township. The most important take-away from these census records is the fact that the 1830 census does indicate that Edward possibly had two sons, who could fit with the assumed birth year of Charles H. Attebery. The 1840 census would seem to reinforce this possibility with listings of one son aged 20 to 29. It does seem possible, simply based on possible age, that Edward could have been the father of Charles H. Attebery.

<u>James Arterbury</u>: The household of James Arterbury was recorded in 1830 in Howard County MO, summarized as follows:

This household was listed on Page 69 of 96, immediately abutting the households of James Arterbury Sr., Ashford Arterberry and Greenberry Atterbury. Because of their close living proximity, there is good reason to believe that this James, Ashford and Greenberry were all sons of James Arterbury Sr. and Dorcas, his presumed wife. James Arterbury Jr. was purportedly born in about 1784 in Chester County SC. James Arterbury Sr.'s household was recorded in Grayson County KY in 1810, summarized as follows:

In this census record James Sr. was recorded with an apparent six sons, three of whom could have been born before 1794, and two born between 1795 and 1800. Presumably, James Arterbury Jr. would have been one of those sons born before 1794. James E. Branch⁴ reports that James and Dorcas had children as follows:

Since James Arterbury Sr. died intestate, and before 1850, there is no documentary proof in existence of his children. Given the close living proximity of James [Jr.], Ashford and Greenberry in the 1830 census, the researcher is inclined to accept these men as children of James and Dorcas.

The composition of James Arterbury Jr.'s household in 1830 reflects one apparent son, aged 5 thru 9, and two apparent sons aged 10 thru 14. Any one of these three apparent sons could have been of an age to have been Charles H. Attebery, i.e. born 1820 (+/- 1 year). The critical question is whether James Arterbury Jr. could have been in Missouri by 1820. The earliest known record of James Arterbury Jr. was his marriage summarized as follows:

Many Atterbury researchers claim that James Atterbury Jr. married his 1st cousin, Elenor Atterbury, daughter of William Atterbury Jr. and his wife, Bridget [poss. Murray]. Whether or not the identity of James Atterbury's wife is correct, it seems a virtually certainty that this was the marriage of James Arterbury [Jr.], son of James Arterbury [Sr.]. James Arterbury Jr.'s household was recorded in 1840 and 1850, and possibly in 1860, summarized in Figure 3, below:

It should be noted that James Atterberry Jr.'s household was recorded immediately adjacent to Williamson Atterberry in Platte County MO in 1840, immediately adjacent to James Atterberry Jr. [III] in Platte County MO in 1850, and immediately adjacent to Thomas W. Atterberry in Clinton County MO in 1860. Given the close living proximity between James Atterberry Jr. and other Atterberrys in those three census years, there is good reason to believe that James [III], Williamson and Thomas W[illis] were his sons. In addition to the above listing of the purported children of James and Eleanor Atterberry from James E. Branch, he also offered the following additional biographical information:

The above information suggests that James Atterberry probably died intestate, and that his estate was administered through the Court, yet the researcher was unable to locate any estate record for

James Jr. He is reported by James E. Branch to have died in Clinton County MO in 1867. If the estate information offered by James E. Branch is correct, then we would appear to have

confirmation of at least three of James and Eleanor's sons: Thomas, Shelton and Williamson. We have also identified a possible 4th son with the identity of James [III]. This would seemingly leave two sons unidentified. James E. Branch listed yet another son, John T. Atterberry. There does appear to have been a son named John J. Atterberry still living in James' household in 1850, whose age matches with James E. Branch's data for John T. If correct, this would appear to leave one son unidentified. It seems entirely possible that that missing son could have been Charles H. Attebery.

First, we should try to establish whether James Atterberry Jr. was in Missouri early enough to have had a son named Charles H. Atteberry, born in 1820 in Missouri. Such prospect would seem to be confirmed by the census records for his presumed sons: Thomas and Shelton, both of whom were reported born in Missouri in later census records. Thomas purportedly was born about 1818 in Missouri, whereas Shelton was reported born in Missouri in about 1822. This data would seemingly guarantee that James Arterbury Jr. was living in Missouri [probably Howard County] before 1818, amply early to have been the father of Charles H. Attebery.

In support of the case for James Arterbury Jr. having been the father of Charles H. Attebery, we offer the grave marker of Eleanor Attebery in Figure 4. This grave marker clearly shows Elenor Attebery to have been the wife of James Attebery. The spelling of Elenor's surname as "Attebery" is particularly noteworthy. From almost 20 years of researching the Atterbury family, the researcher has encountered very few instances of this rather unique spelling. The Charles H. Attebery family is one of the very few instances of this spelling ever encountered. Yet the grave marker seems to suggest that that was the same spelling adopted by the James and Elenor Attebery family. The memorial marker of James Attebury is shown in Figure 5. Both James and Elenor are reported (Find-A-Grave) to have been interred at Lebanon Church Cemetery near Starfield, Clinton County, Missouri. Note that James Attebery's surname was also spelled with a single "r". Although not definitive in itself,

these matches of surname spellings adds compelling evidence to the identification of Charles H. Attebery as a son of James Jr. and Elenor Attebery. Such prospect is further supported by the land patents filed by James *Attebery* in Missouri.

<u>William Atterberry</u>: The final Atterberry family from Table 1 awaiting our analysis is the listing for William Atterberry, whose household in 1830 in Union County is summarized as follows:

According to James E. Branch, this William Atterberry was another son of James [Sr.] and Dorcas Atterberry. Such kinship may be accurate, particularly when we consider the demographics associated with his children. If we accept the identity and demographics for these purported children, the son named Adin was born about 1816 in Hardin County KY, whereas the next younger son, Daniel, was purportedly born in 1818 in Missouri. Also, each child born after 1818 was purportedly born in Missouri. And further, the ages of each young male reported in William's household in 1830 comport with the ages reported for each of William's sons claimed by James E. Barnch. That being the case, even though William Atterberry appears to have been in Missouri around 1817, all of his sons appear to be identified (none missing). Moreover, it should be noted that William Atterberry named his 5th born son Charles H. Given his reported date of birth as 1827, he clearly was not the Charles H. Attebery who is subject of our current investigation. But the emergence of the name, Charles H., within the William Atterberry (son of James and Dorcas) lineage would seem to lend support to our Charles H, having been a son of William's brother, James Jr.

This concludes our analysis of the potential paternal households for Charles H. Attebery recorded in Missouri in 1830. In this analysis we identified a total of five different households reporting sons potentially matching the birth year of Charle H. Attebery. Two of those households are believed headed by descendants of James and Dorcas Atterberry: James Arterbury Jr. and William Atterbury. The ancestry of the other three potentially matching households headed by Simeon Atteberry, Zachariah Arterury and Edward Arterbury is less certain. Since none of these five potential households could be traced backward before 1830, it was not possible to establish their ancestry with any degree of certainty. Similarly, there were no estate records found by the researcher which might have provided clues of kinship. However, other researchers and writers were found, which did suggest kinship connections for Edward Arterbury, and for James Atterberry Jr. One such reference suggested the existence of an estate administration record which appeared to connect Edward Arterbury as a son of Thomas and Laraney Atterberry.

CONCLUSION

Having investigated and analyzed all six of the Atterbury families recorded living in Missouri in 1830 and having male children matching Charles H. Attebery's demographics, the researcher is inclined to believe that Charles H. Attebery of Macoupin County IL was a son of James Attebery II and Elenor Attebery. This conclusion is based on several items of circumstantial evidence:

- 1. Charles H. Attebery reported his year and place of birth in three separate census records as having been 1820 in Missouri.
- 2. Only five Atterberry households were recorded in the 1830 census in Missouri with young male(s) matching Charles H. Attebery's demographics.
- 3. James Attebery Sr. was the only Atterberry appearing to have had sons born in Missouri before 1820: Aden Atterberry born in Kentucky in about 1816, Williamson Attebery born in Missouri in about 1818, Shelton Attebery born in Missouri in about 1822 (documented in later census records).

- 4. James Attebery Sr. was recorded in 1810 census in Kentucky with six apparent sons in his household, ranging in age from under 10 thru 25. All of those sons except one have been reliably identified from census, estate and/or land records. The missing son fits with the age of Charles H. Attebery
- 5. William Attebery, son of James Attebery Sr., named a son Charles H. Attebery, born about 1827 in Missouri, suggesting that that name may have held special significance in the James Attebery Sr. family.
- 6. James Attebery Sr. and his descendants appear to have adopted the rather unique surname spelling form of "Attebery". This unique spelling comports with the surname corruption adopted by Charles H. Attebery, which is in itself a strong indicator of close kinship connection between Charles H. Attebery and the James Attebery Sr. family.
- 7. Charles H. Attebery named his 1st born son "James Edward", suggesting that his father or grandfather may have been named James.

After carefully considering all of the foregoing circumstances, the researcher believes it highly probable (greater than 90%) that Charles H. Attebery was a son of James Attebery II and Elenor Atterberry.

Assuming this familial connection to be correct, the researcher has compiled both a Pedigree Chart and a Descendants Chart for Stanley Edward Attebery, extending backward for ten generations to William Arthurbury and Anne Oliver of Morden Parish, Surrey County, England, in the 17th Century. These charts are attached to this final draft report as appendices, and attached to the profile of Elmer Claude Attebery on the *Elmer Claude Attebery Family* public tree on Ancestry.com.
